

## Refeyn Travel Grant Terms and Conditions

The purpose of these Terms is to outline the terms and conditions under which Refeyn shall offer, award, make, promise, pay out or otherwise commit to any financial support towards research within the field of mass photometry (“the Grant”). Consequently, the Grantee (as defined below) shall be bound by these Terms, unless otherwise specifically agreed in writing by the Grantee upon at the time of acceptance.

**1. Grant Application and Grantee.** Any Grant to be considered by Refeyn shall be applied for in writing using the application form available on the Refeyn website. The Grant shall be awarded to the person appointed by Refeyn in its sole discretion as the grant recipient (“the Grantee”) who shall also act as the primary contact person vis-à-vis Refeyn and be responsible for proper usage of the Grant from a scientific, financial and legal perspective.

**2. Use of Grant.** The Grant shall be used strictly and solely towards travel expenses associated with the presentation of the research outlined in the Grant application. This includes conference registration fees, travel (flights, trains, public transportation, etc.) as well as accommodation at the venue of the conference where the research will be presented.

**3. Grant Period.** The Grant shall be used before 30 July 2023 (“the Grant Period”). In case the Grant is not used within this period, the Grantee must notify Refeyn and return any unused funds.

**4. Notification of changes.** The Grantee shall immediately notify Refeyn in case a material delay or any change to the presentation of the research is likely to occur. Refeyn reserves the right to withhold the Grant in case of any significant changes.

**5. Payment of Grant.** The Grant shall be paid out in entirety to the Grantee upon receiving proof of acceptance to Refeyn’s reasonable satisfaction that the Grantee’s research will be presented (either an oral presentation or a poster) at the Grantee’s chosen conference. The Grant will be paid out in Pound Sterling, which implies that Refeyn shall not carry the risk of any currency fluctuations. Likewise, any taxes and charges that may become due as a result of payment and receipt of the Grant shall be the responsibility of the Grantee.

**6. Unused Grant.** Any part of the Grant which has not been duly spent on travel expenses within the Grant Period shall be returned to Refeyn by the Grantee no later than 90 days after the expiry of the Grant Period.

**7. Publicity Agreement.** The Grantee is aware that Refeyn will make public an overview of any and all Grants awarded over a given period of time and accepts and agrees to the fact that their names will appear as part of such overview, which may also include a description of the research presented as well as any associated

institutions. Grantees may opt to work with Refeyn to create additional promotional materials as desired.

**8. Duty to Provide Documentation.** Within 14 days of receiving a written request from Refeyn,, the Grantee shall provide copies of all receipts, invoices, records, and other documentation relating to the Grant, the use of the Grant funds and the adherence by the Grantee to these Terms.

**9. IPR Protection and Publication.** The Grantee shall use their best efforts to pursue publication of their research in recognized international scientific journals. In case of any such publications, the Grantee shall ensure proper recognition of Refeyn by mentioning under “acknowledgments” that the relevant research has been funded through the Grant.

**10. Governing Law and Jurisdiction.** These Terms shall be interpreted and governed in accordance with the laws of England and Wales. Any dispute hereunder which cannot be settled amicably shall be referred to the courts of England and Wales.

**11. Modification of terms.** Refeyn reserves the right to change or modify any of the terms and conditions contained in the Terms of the Grant, at any time and in its sole discretion. Any changes or modification will be effective immediately upon posting of the revisions on the website, and users waive any right they may have to receive specific notice of such changes or modifications.
